

**CHAPTER SIX - Section 6.08**  
**TENNIS AND BASKETBALL COURTS**

**I. POLICY**

The following ~~Rules and Regulations~~ **policies** shall be in force with respect to the use of LMOA tennis and basketball courts:

~~A.~~ **General**

- ~~1.A.~~ Large groups (more than 8) shall make prior ~~arrangement~~ **arrangements** with the General Manager to use ~~the~~ tennis courts.
- ~~2.B.~~ Proper tennis or other soft-soled shoes shall be worn on all courts. ~~Hard-soled shoes are~~ **Skating or bicycling is** not permitted.
- ~~3.C.~~ Tennis players are encouraged to wear proper tennis attire. ~~-~~ Playing tennis without a shirt is not permitted.
- ~~4.D.~~ Skateboards, roller skates and deck hockey are permitted on the basketball ~~court~~ **courts** only. ~~-~~ Bicycles **and tricycles** are not permitted on the tennis ~~or courts at any time.~~ **Tricycles are allowed on the** basketball courts ~~at any time~~ **but bicycles are not.**
- ~~5.E.~~ ~~Radios, tape recorders, etc. are~~ **E. Loud music is** not allowed in or around the court areas.
- ~~6.G.~~ Pets are not permitted on the courts at any time.
- ~~7.~~ ~~Proper identification is required when using the tennis courts.~~

**B.II Playing Rules GENERAL RULES AND REGULATIONS**

- ~~1.A.~~ If players are waiting for tennis courts, play shall be limited to 1 hour. ~~-~~ **for singles and 1 1/2 hours for doubles.** Doubles are encouraged when players are waiting.
- ~~2.B.~~ ~~Unsupervised children are not permitted inside the fenced area when play is in progress.~~ **Children under 12 must be supervised by an adult.**
- ~~3.C.~~ Users of tennis and basketball courts shall be responsible for the disposal of all trash ~~and the closing of gates when they leave the courts.~~

**III. ASHLAWN TENNIS COURTS RULES AND REGULATIONS**

- A. When not in use, the Tennis Courts will be locked.**
- B. Only tennis members, guests and day use players are allowed on the Tennis Courts.**
- C. Tennis Members**
  - 1. Only tennis members will be given the combination to the gate's combination lock.**
  - 2. A list of paid tennis members will be displayed on the board located by the entrance to the Tennis Courts.**

3. **Guests and dependant children under 18 years of age of tennis members may play tennis only when accompanied by the tennis member. There are no fees for guests and dependant children.**
  - a. **A tennis member may bring each guest no more than seven times per year.**
  - b. **There is no limitation on the amount of play of dependent children.**

**D. Day Use Tennis Players**

1. **A fee for day use of Ashlawn Tennis Courts by residents shall be set annually by the Board of Directors and shall be included in the schedule of dues, assessments, charges and fees.**
2. **Day use tennis players shall pay the fee at the Main Gate and receive a key to the Tennis Courts' lock. Their drivers' license will be held at the Main Gate until the key is returned.**
3. **When finished, day use tennis players will return to the Main Gate and exchange the Tennis Courts' lock key for their drivers' license.**

**E. Guests**

1. **A daily guest fee for the use of Ashlawn Tennis Courts shall be set annually by the Board of Directors and shall be included in the schedule of dues, assessments, charges and fees.**
2. **Guests may play tennis only when accompanied by a tennis member or day use tennis player.**
3. **The daily guest fee shall be waived for children 18 years of age or younger.**
4. **Proper identification is required when using the Tennis Courts.**

**IV. Lafayette Tennis Courts**

- A. **The Lafayette Tennis Courts are available for use by owners, tenants,-their families and guests from dawn to dusk.**
- B. **There are no fees for use of the Lafayette Tennis Courts.**
